
The Curriculum and Assessment Review, chaired by Professor Becky Francis CBE, has been set up to undertake a review of the current national curriculum and statutory assessment system in England.

Spanning Key Stage 1 to Key Stage 5, the review will look closely at the key challenges to attainment for young people, and the barriers which hold children back from the opportunities and life chances they deserve – in particular, those who are socioeconomically disadvantaged, or with special educational needs or disabilities (SEND).

On 25 September, the review launched an 8-week call for evidence seeking the views of young people and parents, teachers and lecturers, leaders, experts, and employers on the strengths and weaknesses of the current system and how it can be improved. These views will be pivotal to the recommendations the review puts forward in 2025.





How long is the call for evidence open for?

The call for evidence opens on 25 September and runs for 8 weeks until 22 November.

Who is the call for evidence aimed at?

This consultation welcomes views from everyone with an interest in curriculum and assessment from Key Stage 1-5 in England. This includes young people and parents, teachers and lecturers, leaders, experts and employers.

How do I submit evidence to the review?

There are several ways to engage with the review throughout the call for evidence:

What is the overall aim of the Curriculum and Assessment Review?

- A curriculum that ensures children and young people leave compulsory education ready for life and ready for work. This includes

- An assessment system that captures the strengths of every child and young person and the breadth of curriculum, with the right balance
